# Minutes of the Second Meeting of the Month on Monday 15 February 2010 at the Council Chamber at 7.00pm.

The Mayor welcomed Mr Paul Davies AM, the Assembly Member for Preseli Pembrokeshire to the meeting and there was a wide ranging discussion that opened with the current interest in extending the powers of the National Assembly that was not due to be fought on party political lines given the free vote. Other matters considered included the following.

Education in Wales, especially the future for 16 plus young people in the locality was difficult given the much wider choice of subjects to be offered. Mr Davies noted that the level of expenditure on children in Wales was £527 less per child than in England. In addition budget cuts of 5% in efficiency savings as well as efforts to protect 6<sup>th</sup> forms were presented.

There was a broad point regarding democracy with the view of a 'Broken Society concept from a broken democracy' and the desire of UK and Cardiff government to reduce local councils as well as concerns over the Cabinet form of local government in Pembrokeshire.

Mr Davies responded by emphasising a need for transparency of salaries of councillors and officers and he did not agree with making town and community councils smaller. The alternative approaches for local democracy are difficult albeit a Mayor would be directly elected unlike the Cabinet appointments.

The lack of Broadband service especially north and west of St Davids is a major issue. He felt that efforts to improve it are being made and the use of a wireless service was an option but the government does not seem to be embracing wireless services although communities could bid for funding in some cases.

Property revaluation and potential increases in business rates of as much as 85% were of grave concern. A campaign is being considered in other parts of the county especially Narberth to challenge why businesses are being charged so heavily – no answer being apparent from the government. The lack of clarity was also seen regarding transport with the need for extra train services to Fishguard and in Mr Davies' view the government had sat on the fence.

Policing levels in rural Pembrokeshire especially were noted as a concern and Mr Davies was meeting with the Chief Constable and Chief Superintendent and would bring the matter up once again.

Mr Davies offered to come along to meetings on a more frequent basis and this was much appreciated, the Mayor then thanked him for coming to St.Davids and he left the meeting.
