345.1 Cllr Bethan Price e-mail of 27th November 2019 continuing recent press release re discontinuance of free transport for 16 year old school and college students was received and it was RESOLVED to write to Pembrokeshire County Council outlining the City Council's concerns and objecting to the proposal in the strongest possible terms.

Planning:

- 366** NP/19/0614 Rhosygilwen, SA62 6DB - Conversion of an existing adjoining garage combined with existing residential accommodation to create a new self-catering holiday unit. The City Council considered that the proposal was deemed unlikely to have a detrimental visual or environmental impact on the surrounding area. It was RESOLVED to support the application.
- 367** NP/19/0582 Carn Nwchwn Farm SA62 6QN Variation of diversification project involving the conversion of 3 existing redundant barns to bunkhouse accommodation and associated facilities, staff accommodation, workshop, office food store and launderette. Construction of a small link building between barns 1 and 2 to accommodate kitchen facilities. Creation of parking area and cycle stands. Storage hoppers for biomass pellets and recycling compound. Works to the site access to improve visibility and create 2 passing bays. The City Council considered that the proposal was deemed unlikely to have a detrimental visual or environmental impact on the surrounding area. It was RESOLVED to support the application.
